Cookie policy

This Cookie Policy applies in addition to the Personal Data Policy applicable to the STRATUS LLC website and published at: [https://uavprofsim.com/en/documents/].

This Policy governs the types of cookies that are used on the [uavprofsim.com/en/] website, the purposes and how they are used.

1. Definitions

- 1.1. **Cookies** are small pieces of data sent by the Site server and stored on your device in order to optimise the performance of the Site. For the purposes of this Policy, the definition of Cookies also includes web beacons (pixel tags) and other similar technologies. The use of cookies on the Site is governed by the Cookie Policy [https://uavprofsim.com/en/documents/].
- 1.2. Site means Internet website on the following domain: https://uavprofsim.com/en/
- 1.3. **Site Owner** is STRATUS Limited Liability Company, OGRN: 1223900003800, INN 3906412175, Address: 119607, Moscow, intra-urban territorial municipal district Ramenki, Ramenskiy Boulevard, 1.
- 1.4. **User** means any individual or entity in any state who uses or accesses the Site.

2. Purposes and Scope of this Policy

- 2.1. The purpose of this Policy is to inform visitors to the Site about the types of cookies used on the Site, the purposes for which cookies are used by the Site Owner, and how to disable and/or delete them from the User's device.
- 2.2. This Policy applies only to the Site and does not regulate the use of Cookies on third party sites, which can be accessed via links on the Site. The owner of the Site does not bear any responsibility for the content of such third-party sites and the ways and conditions of collection and processing there of personal data of Users, including Cookies.
- 2.3. By continuing to use the Site, the User expresses his/her unconditional consent to this Policy. In case of disagreement with the Policy, the User is obliged to stop using the Site.

3. Types of Cookies Used

- 3.1. The cookies used on the Site are categorised by their retention period into:
 - 3.1.1.Session Cookies are stored in the User's web browser (other web client) only for the duration of an active session on the Site (i.e. until the Site or the entire browser is closed).
 - 3.1.2. Persistent Cookies are stored in the User's web browser (other web client), including after the end of an active session on the Site for a certain period of time (including until deleted). These Cookies ensure memorisation of the User's settings on the Site.
- 3.2. Cookies used on the Site are categorised by purpose:
 - 3.2.1.Technical Cookies are necessary for the correct and smooth operation and provision of the full functionality of the Site to the User. In particular, the use of technical cookies is required to register the User on the Site and facilitate subsequent authorisation of the User.
 - 3.2.2.Analytical Cookies are necessary to collect information about the User's visit to the Site, user path, possible errors in the operation of the Site, statistical data on the Users' work with the Site.

- 3.2.3.Functional Cookies help customise the content of the Site to suit the individual User and personalise the user experience on the Site.
- 3.2.4.Marketing Cookies are used to collect information about User preferences and optimise the display of information and promotional messages and offers to Users. o
- 3.2.5.Third party cookies are necessary to collect information about visits to the Site by analytics platforms providing relevant services to the Site Owner and/or to provide information, marketing or advertising content on the Site with the help of third parties.
- 3.3. The Website uses the web analytics service Yandex.Metrika, owned by YANDEX LLC, 16 L. Tolstogo St., Moscow, 119021, Russia, which helps to collect and analyse information about Users' activity on the Site, track sources of traffic and advertising without identifying specific Users. This information is transmitted to Yandex LLC and stored on its own servers for further processing, the purpose of which is to compile reports on the use of the site and provide other services in accordance with the terms of service Yandex.Metrica. The User may refuse the use of cookies used by Yandex.Metrica by installing the Yandex.Metrica Blocker (https://yandex.com/support/metrica/general/opt-out.html?lang=ru).
- 3.4. The website uses Google Analytics, a web analytics service provided by Google Ireland Limited, which helps to collect and analyse information about Users' activity on the website, track sources of traffic and advertising without identifying specific Users. This information is transmitted to Google Ireland Limited and stored on its servers. The User can read more about the terms of use of Google Analytics on the official website: https://marketingplatform.google.com/about/analytics/terms/ru/. The User may refuse the use of cookies used by Google Analytics by installing the Google Analytics Disable Extension (https://tools.google.com/dlpage/gaoptout/eula.html?hl=ru).
- 3.5. The User's selection of the default settings of the Site by clicking the "Accept" button when accessing the Site for the first time constitutes consent to the use of all types of Cookies.

4. Procedure and Purposes of Using Cookies

- 4.1. When the User opens the Site, the User's web client, through the use of Cookies, provides the Site with certain information about the User's activities on the Site and/or the User's settings on the Site.
- 4.2. The use of Cookies on the Site is necessary for the following purposes:
 - 4.2.1.ensuring the functioning and security of the Site, improving its operation;
 - 4.2.2.improving the user experience of using the Site, optimising the design and structure of the Site for convenience and speed of the User's search for necessary information and performance of necessary actions on the Site;
 - 4.2.3.registration of the User on the Site and saving the User's authorisation status after registration, as well as identification of the User at each new access to the Site (recognition of the User's device and/or browser, saving the User's browser and/or screen settings, saving login and password for authorisation on the Site);
 - 4.2.4.collection and analysis of information on the use of the Site by Users, User sessions, statistics on the use of the Site, analysis of the visits the Site by Users;
 - 4.2.5.collection and analysis of marketing information (in particular, about the User's clicking on advertising and information links on the Site), personalisation of offers and advertisements for the User on the Site and increasing their effectiveness.
- 4.3. When visiting the Site for the first time, the User will see a pop-up window inviting him/her to read this Policy, as well as to provide his/her consent to the use of all or only

technically necessary Cookies. Technical Cookies are set and start to be used automatically, unless otherwise defined in the User's web client (web browser) settings.

4.4. The information that is collected through the use of Cookies is stored and processed by the Site Owner and/or its partners in accordance with the Personal Data Policy available at: [https://uavprofsim.com/en/documents/].

5. Disabling Cookies

- 5.1. The User can set and change the use of Cookies on the Site by changing the corresponding settings in the web client (web browser).
- 5.2. Having consented to the use of Cookies, the User can delete stored Cookies at any time using the settings of his/her browser, as well as change the settings of the Site.
- 5.3. The user may disable cookies on the Site through the settings of their web client (web browser).
- 5.4. The User should take into account that the full functionality and availability of the Site (in particular, the User's registration on the Site) is ensured only by consenting to the use of all types of Cookies.
